- I. INVOCATION
 - Invocation was led by Dr. Wyben R. Briones.

II. PHILIPPINE NATIONAL ANTHEM

- It was led by Dr. Julio L. Gonzalez. Music video of the Philippine National Anthem was played.
- III. CALL TO ORDER Chairman of the Board
 - Meeting was called to order by Dr Amado Enriquez, Jr. at 8:04 AM.

IV. DECLARATION OF QUORUM

 Out of the 170,557 total outstanding shares of Corporation, 67.1% or 114,444 shares of the total issued, and outstanding shares are present either in person or by proxy. Dr Velma Chan, Corporate Secretary, declared that there is a quorum.

V. WELCOME MESSAGE

- Dr. Amado Manuel C. Enriquez, Jr. announced that after 5 years ACEMCCEBU is about to start operations.
- He wished all the stockholders well during the pandemic.
- He expressed his gratitude to General Roy Cimatu of the local IATF, Dr. Jaime Bernadas, Regional Director of DOH7, and Dr. Sophia Mancao, Head of the Licensing Division of DOH7 for their support.

VI. READING AND APPROVAL OF THE MINUTES OF THE 2019 ANNUAL STOCKHOLDERS' MEETING

- Dr. Velma Chan read the minutes of the 2019 Annual Stockholders' Meeting.
- Dr. Marietta Samoy moved for the approval of the minutes of 2019

VII. TREASURER'S REPORT

- Treasurer Ms. Floram Limotlimot presented the Audited Financial Statements for the fiscal year ended December 31, 2019. The Audited Financial Statement is included in the Y2020 Annual Report or SEC Form 17-A. She stated that the Report was duly audited by the Company's External Auditors, Minerva & Company, CPAs and has a comparative Financial Position covering 2018 and 2019. VIII. PRESIDENT'S REPORT

Dr Geanie Cerna Lopez presented the following:

A. MILESTONES OF ACEMC - CEBU

- July 17, 2020 ACE Medical Center Cebu was finally granted its Full Occupancy Permit.
- July 30, 2020 The DOH R7 Licensing Team visited ACE Medical Center Cebu for its inspection as a Level 1 facility.
- August 3, 2020 ACE Medical Center Cebu was granted its License to Operate as 50-bed Primary Care Facility with an Infirmary service capability. It is valid until December 31, 2020.
- B. Presented in a video presentation the status of ACEMC Cebu.

C. COVID Preparation

• Modifications in compliance to DOH and IATF requirements.

- Presented the COVID section, which has a different pathway, hence, not mixing COVID cases with clean cases.
- Dr. Cerna presented the renovation sketch plan of the temporary office for conversion into the ARI-D clinic.
- Dr. Cerna presented the pathway for the COVID floor which will be accessed via the service elevator from the basement. It will have a centralized negative pressure, hepa filters, cameras and its own operating room and delivery room, and ICU. Dedicated personnel to be assigned to said floor. It will be a restricted zone.

D. Lack of Nurses

Dr. Cerna presented that with the full occupancy certificate issued to ACEMC – Cebu, it can operate with a total of 176 beds. Due to the shortage, it is not possible to do so. Currently, ACEMC – Cebu has a total of 34 nurses enough to operate the 50-beds. The compensation package of ACEMC – Cebu is more competitive than other hospitals to attract more applicants. Since the plan is to open more beds as more nurses come in.

E. The Chairman's Vision

The establishment of ACE hospitals all over the country is a vision of our Chairman, Dr. Amado Manuel C. Enriquez, Jr. together with our group of doctors in Manila, who have 10 to 30 years of experience in building and managing hospitals. It is a sacrifice born out of the altruistic desire to share our expertise to our colleagues.

F. A Challenge to Cebu-based Founders

 Dr. Cerna challenged all the Cebu-based founders and stockholders to rise to the challenge of making ACEMC – Cebu a great success as a legacy to your names and to your children's children.
