MINUTES OF THE MEETING:

- I. INVOCATION
 - Invocation was led by Dr. Ma. Asuncion Hipolita Libre.

II. PHILIPPINE NATIONAL ANTHEM

- A music video of the Philippine National Anthem was played.
- III. CALL TO ORDER Chairman of the Board
 - The meeting was called to order by Dr Amado Enriquez, Jr. at exactly 8:00 AM.

IV. DECLARATION OF QUORUM

- 86% of the total outstanding shares or 147,703 shares were present either in person or by proxy (Annex "D"). Dr. Marietta T. Samoy, Corporate Secretary, confirmed the presence of a quorum to validly call the meeting.
- The directors and officers were introduced to the stockholders. Their business profiles are shown in Annex "A". Likewise, the Directors'

attendance for year 2020 (Annex "B") and Performance Assessment Report (Annex "C") are presented herewith.

V. WELCOME MESSAGE

- Dr. Amado Manuel C. Enriquez, Jr. discussed the challenges that the
 corporation is facing such as the: ongoing effect of the Covid-19 pandemic
 which has caused a downward trend in the economy, Philhealth collection
 problems, Department of Health Suggested Retail Price on various
 pharmaceutical products, effect of the government hospitals, officials and
 candidates for the upcoming elections, and scarcity of nurses nationwide
 and worldwide.
- He attributes resiliency as the key against the challenges that the hospital is facing.
- He acknowledged the Board of Directors, officers, and founders for a job well done, for sharing their wisdom and vast experience unconditionally to attain its goals and success in all of its endeavors.

VI. READING AND APPROVAL OF THE MINUTES OF THE 2020 ANNUAL STOCKHOLDERS' MEETING

- Dr. Fay Jasmine de los Santos-Torrevillas moved to dispense with the reading of the minutes and to approve the same. It was seconded by Dr. Julio Gonzalez.
- The chairman inquired if there were objections to the motion, but there
 were none posted in the chat box. A total of 147,703 outstanding shares
 present approved to dispense with the reading and approved the minutes
 of the year 2020 Annual Stockholders Meeting.

VII. TREASURER'S REPORT

- The Treasurer, Dr. Enjel A. Gabriel, presented the Audited Financial Statements for the fiscal year ended December 31, 2020. The Audited Financial Statement is included in the Y2020 Annual Report or SEC Form 17-A. She stated that the Report was duly audited by the Company's External Auditors, Minerva & Company, CPAs. The report is available at the Company's website.
- The highlights of Dr. Gabriel's financial report are as follows:
 - 1. Statement of Financial Position
- a. Total Assets (Current Assets and Non-current Assets)

In 2020, ACE Medical Center-Cebu had a total asset of Php 1,369,208,143.00 versus that of 2019, which was Php 1,274,941,249.00 or a 7% increase in total assets.

b. Total Liabilities and Stockholders' Equity

Total Liabilities (Current Liabilities and Non-current Liabilities)
In 2020, ACE Medical Center-Cebu had a total liability of Php 888,339,710.00 versus that of 2019, which was only Php814,944,465 or a 9% increase in total liabilities.

Total Stockholders' Equity

In 2020, ACE Medical Center-Cebu had a total stockholders' equity of Php 480,868,433.00 verus that of 2019, which was only Php459,996,784.00 or a 4% increase in total stockholders' equity.

ACE Medical Center-Cebu had a total of Php1,369,208,143.00 in total liabilities and stockholders' equity, which was a 7% increase versus that of 2019 at Php1,274,941,249.00.

2. Statement of Comprehensive Income

a. Total Income

In 2020, ACE Medical Center-Cebu had a total income of Php 2,621,317.00, which is higher compared to that of 2019 and 2018 at Php 1,098,490.00 and Php1,221,021.00, respectively.

b. Total Comprehensive Loss (net of expenses, taxes)

In 2020, ACE Medical Center-Cebu had a total comprehensive net **loss**, after general and administrative expenses, finance cost, and taxes, amounting to PHP 23,751,057.00, which is a slight improvement versus 2019 at PHP 24,629,712.00 but overly higher than 2018 at PHP 14,852,294.00.

Considering the above financial condition, no dividends were declared in 2020.

The Company has not paid any compensation to the officers except for the one-time exemplary service fee paid to two officers amounting to Php 4,400,000.00 in 2019.

As of December 31, 2020, there were no transactions with related parties.

- December 1, 2020 ACE Medical Center Cebu was granted a 175-bed Level II License to Operate with an Authorized Type II Ambulance Unit.
- December 11, 2020 ACE Medical Center Cebu applied for License to Operate renewal.
- December 23, 2020 ACE Medical Center Cebu had its blessing and inauguration.
- December 26, 2020 ACE Medical Center Cebu opened its doors to the public.
- January 2, 2021 ACE Medical Center Cebu had its first admission.
- January 4, 2021 ACE Medical Center Cebu had its first major operation (Craniotomy).
- January 6, 2021 ACE Medical Center Cebu was granted its PhilHealth Level II accreditation covering the period December 15 to 31, 2020.
- January 28, 2021 ACE Medical Center Cebu was granted its continuous accreditation for the period January 1 to December 31, 2021.

- C. Upcoming plans of ACE Medical Center Cebu, which are as follows:
 - 1. Hemodialysis Unit (within the next 12 months);
 - 2. Maxillo-facial Center and a Fertility Center;

 - 4. Level III License to Operate.
