AMENDED ARTICLES OF INCORPORATION

ALLIED CARE EXPERTS (ACE) MEDICAL CENTER-CEBU INC.

Know All Men By These Presents:

That we, of legal age, and residents of the Philippines, on this day voluntarily associated ourselves together for the purpose of forming a corporation under and in accordance with the laws of the Republic of the Philippines.

And We Hereby Certify:

Articles 1

That the name of the corporation shall be:

ALLIED CARE EXPERTS (ACE) MEDICAL CENTER-CEBU INC.

Article II

That the purposes for which said corporation is formed are:

Primary Purpose

To establish, maintain, operate, own and manage hospitals, medical and related healthcare facilities and businesses such as but without restriction to clinical laboratories, diagnostic centers, ambulatory clinics, condo-hospitals, scientific research and other allied undertakings and services which shall provide medical, surgical nursing, therapeutic, paramedic or similar care, provided that purely professional, medical or surgical services shall be performed by duly qualified and licensed physicians or surgeons who may or may not be connected with the hospitals and whose services shall be freely and individually contracted by the patients.

Secondary Purposes

- 1. To purchase, acquire, own, lease (except financial leasing), sell and convey properties such as lands, buildings, factories and warehouses and machineries, equipment and other personal properties as may be necessary or incidental to the conduct of the corporate business and to pay in cash, shares of its capital stock, debentures and other evidences of indebtedness, or other securities, as may be deemed expedient, for any business or property acquired by the corporation.
- To import, export, buy, sell or deal, as principal or in a representative capacity or as manufacturer's representative, in merchandise, drugs, pharmaceutical products, medicines,

chemicals, cosmetics, perfumeries, toilets, articles, surgical apparatus, physicians' and hospitals' supplies, equipment, optical supplies, and such other materials related to the primary purpose.

- To import, export, buy, sell and generally deal in all kinds of machinery, equipment as well as
 chemicals, appliances and instruments, extracts, compounds and materials required for such
 operations and related to the primary purpose.
- To establish, adopt and maintain a system of a prepaid professional, medical, nursing, paramedical and hospitalization services.
- To own, manage, run, operate gift shops, magazine stands, drug stores, soda fountains, canteens and refreshment parlors.
- 6. To borrow or raise money from not more than nineteen (19) lenders including its stockholders necessary to meet the financial requirements of its business by the issuance of bonds, promissory notes and other evidences of indebtedness, and to secure the repayment thereof by mortgage, pledge, deed of trust or lien upon the properties of the corporation or to issue pursuant to law shares of its capital stock, debentures and other evidences in payment for properties acquired by the or for money borrowed in the prosecution of its lawful business.
- 7. To invest and deal with the funds and properties of the corporation in such manner as may from time to time be considered wise or expedient for the advancement of its interest and to sell, dispose of or transfer the business, properties and goodwill of the corporation or any part thereof for such consideration and under such terms as it shall see fit to accept.
- 8. To enter into any lawful arrangement for sharing profits, union of interest, unitization or farm out agreement, joint venture, reciprocal concession, or cooperation, with any corporation, association, partnership, syndicate, entity, person or governmental, municipal or public authority, domestic or foreign, in the carrying on any business or transaction deemed necessary, convenient or incidental to carrying out any of the purposes of this corporation.
- 9. To acquire or obtain from any government or authority, national, provincial, municipal or otherwise, or any corporation, company or partnership or person, such charter, contracts, franchise, privileges, exemption, licenses and concessions as may be conducive to any of the objects of the corporation.
- 10. To establish and operate one or more branch offices or agencies and to carry on any or all its operations and business without any restrictions as to place or amount including the right to hold, purchase or otherwise acquire, lease, mortgage, pledge and convey or otherwise deal in and with real and personal property anywhere within the Philippines.
- 11. To apply for, register, hold, own, use, sell, assign, or otherwise dispense trademarks, trade names, patents, inventions, formula and processes in connection or resulting there from.

- 12. Subject to existing laws, to purchase, acquire, hold, dispose, of or otherwise deal in shares, stocks, bonds, securities of any corporation having subjects altogether or in part similar to those of the corporation and while the holder thereof, to exercise all the rights and incidents of ownership, including the right to vote the same and to receive dividends and dispose of the same.
- 13. Without limiting any of the foregoing purposes and objects, do and perform and conduct such acts of things whatsoever which are necessary or incidental to the purposes of the corporation and in general, to do perform and to exercise such powers.
- 14. To guarantee, for and in behalf of the corporation obligations of other corporations or entities in which it has lawful interest;

Article III

That the place where the principal office of the corporation is to be established or located is in <u>982 N. BACALSO AVENUE</u>, <u>BRGY. BASAK</u>, <u>PARDO, CEBU CITY, PHILIPPINES</u>, 6000.

Article IV

That the term for which said corporation is to exist is FIFTY (50) YEARS from and after date of incorporation.

ARTICLE VII

That the authorized capital stock of the corporation is <u>TWO HUNDRED FORTY</u>

<u>MILLION (PHP240,000,000.00)</u> PESOS divided into <u>TWO HUNDRED FORTY THOUSAND</u>

(240,000) shares with the par value of <u>ONE THOUSAND</u> (PHP 1,000.00) PESOS per share divided as follows:

- a) TWO HUNDRED THIRTY NINE THOUSAND FOUR HUNDRED (239,400) COMMON shares with a par value of ONE THOUSAND (PHP 1,000.00) PESOS per share;
- b) SIX HUNDRED (600) FOUNDER'S shares with a par value of ONE THOUSAND (PHP 1,000) PESOS per share.

(As Amended on November 12, 2016)

That rights, preferences, restrictions and qualification on the shares of stocks which shall be printed on the stocks certificate, are as follow:

The holders of the founder's share shall have the exclusive right to vote and be voted upon in the election of directors for a limited period not to exceed five (5) years. The five (5)-year period shall commence from the date of registration with the Securities of Exchange Commission.

Transfer or otherwise disposal of shares shall observe the following priorities:

- 1. First Priority- to the corporation which must exercise its option within (30) days from date of receipt of the written offer by the Secretary of the corporation.
- Second Priority- to holders of founder's shares who must exercise their option within like period of thirty (30) days from the receipt of the written offer of the Secretary of the Corporation.
- Third Priority- to holders of common shares who must likewise exercise the option within a
 period of thirty (30) days from the receipt of the written offer by the Secretary of the
 Corporation.
- Fourth Priority- to outsiders who must likewise exercise the option within thirty days from receipt of the written offer from the Secretary of the Corporation.

The foregoing restrictions shall not apply to the dispositions by the stockholders by will, donation, inheritance, bequest, and related transfer of said shares.

Any transfer of a share of the capital stock in violation of the foregoing provisions shall be null and void and shall not be transferable in the books of the corporation.

Article VIII

That the amount of the said capital stock which has been subscribed is ONE HUNDRED TWENTY MILLION PESOS (PHP 120,000,000.00) PESOS, Philippine Currency, and the following persons have subscribed for the kind and number of shares set out opposite their respective names, to wit
